

## DEFINED DURATION 10 ETF (DDX)

### WHY DDX?

#### 1. PLANNING BASED.

The Defined Duration 10 ETF seeks a balance of growth of capital and capital preservation. The Fund is designed to be utilized across 7-15 year time horizons to match to specific financial planning needs.

#### 2. 10 YEAR ASSET ALTERNATIVE.

Most multi-asset stock/bond funds allow the market cap of the stock market to dominate the fund's volatility which may result in excessive volatility at the most unpredictable times. The goal of DDX is to provide an alternative solution to better control volatility skew and help maintain more predictable returns over 10 year time horizons while maintaining balanced goals of growth and principal stability.

#### 3. COUNTERCYCLICAL REBALANCING.

The fund maintains a more consistent average defined duration profile by rebalancing in a countercyclical manner. Unlike "balanced funds", which often allow the stock market to dominate volatility, DDX targets better control for balance which may help create more stable returns over the expected 10 year time horizon.

#### 4. SYSTEMATIC. LOW COST. TAX EFFICIENT.

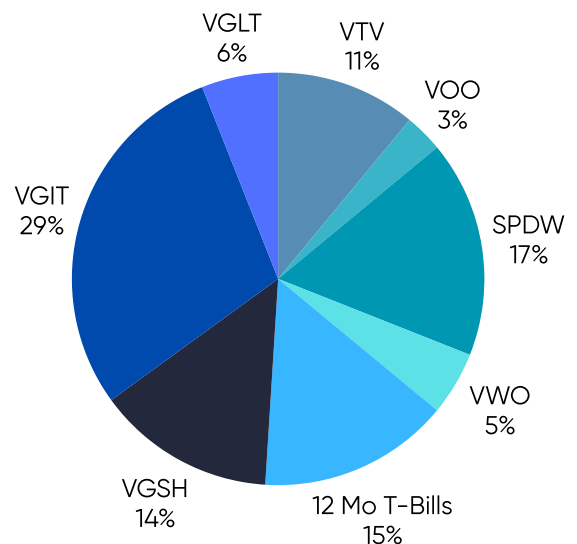
DDX is an elegant, but simple ETF that maintains low costs and a tax efficient rebalancing methodology. It does all of this in a diversified, algorithmic and systematic fund of funds structure.
